MEMORANDUM OF UNDERSTANDING

Between

and
SOUTHVILLE INTERNATIONAL SCHOOLS AND COLLEGES
REPUBLIC OF THE PHILIPPINES

Southville International Schools and Colleges, Philippines and Jyoti Nivas College Autonomous Bangalore, India, hereafter referred to as **SISC and JNC**, agree to enter a formal partnership agreement based on the foundation of mutual trust for the mutual benefit and development of the two institutions and the promotion of international understanding and goodwill.

1. The two institutions resolve to exercise reasonable efforts to promote the following programs:

- (1) Exchange of students
- (2) Exchange of faculty, staff, researchers
- (3) Exchange of academic information and publications
- (4) Joint research activities
- (5) Summer school/Winter school/short term program participation
- (6) Joint organizers of international research conferences
- (7) Virtual/Online Exchange Program
- (8) Other exchanges of academic and cultural nature agreed upon by both parties

2. The implementation of exchange based on this agreement shall be separately negotiated and determined by both institutions.

3. Nothing shall diminish the full autonomy of either institution, nor will any constraint or financial obligation be imposed by either upon the other in carrying out the agreement.



6. This agreement is effective when the representatives of both institutions have signed and dated the document.





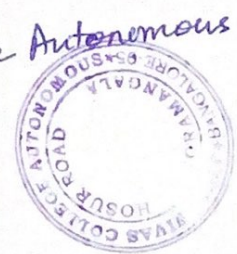
