INSTITUTION'S INNOVATION COUNCIL MEETING

Minutes of the Meeting

The Institution's Innovation Council (IIC) meeting was conducted on 29 April, 2025 at 9.00am in the Botany Lab and the following points were discussed.

Agenda of the meeting

1. Q3 and Q4 IIC calendar activities.

Highlights of the meeting

1. The IIC meeting commenced with a welcome from the IIC President, Dr. Priyadarshini Pillai, who introduced the agenda for discussion. She clarified the schedule of the IIC calendar, stating that Quarter 3 (February–April) and Quarter 4 (May–July) span the key activity periods. She informed members that, considering semester breaks and academic schedules, Quarter 3 activities may be conducted in Quarter 4 and still be reported under Q3 during the report submission process.
2. Ms. Bella shared plans to conduct a gamification activity for postgraduate students as part of student engagement initiatives. She also informed members that the Yukti 2.0 portal is currently open, and students are encouraged to upload their ideas and prototypes. Additionally, she highlighted that even basic and early-stage ideas can be submitted to ThingQbator.
3. During the discussion, Dr. Shilpa Abhang inquired about the submission deadline for uploading ideas to the Yukti portal. In response, Dr. Priyadarshini confirmed that the first week of May would be the ideal window for submission. She also emphasized that ideas presented at recent hackathons are eligible for upload on both Yukti and ThingQbator platforms.
4. As the meeting concluded, Dr. Priyadarshini reminded all members to ensure that details of their department-level IIC activities are uploaded on the institutional intranet for documentation and reporting.

Outcomes of the Meeting

1. Quarter 3 activities can be conducted in Quarter 4 if needed, and reported under Q3 to accommodate semester schedules.
2. Students are encouraged to submit their ideas—from basic concepts to prototypes—on the Yukti portal and ThingQbator, with a submission deadline of the first week of May.

3. Departments must upload documentation of IIC-related activities on the institutional intranet for central reporting and compliance.
